To see if your Lions Club is on the list go on the internet to [www.irs.gov/thelist](http://www.irs.gov/thelist). You also can find a tool kit there to get your club up to date. Most Lions Clubs are listed under International Lions Clubs, but if you have formed a Corporation it would be listed under your Corporation Name.

This is very important as it would hamper your gaming license, your insurance and your club status with LCI.

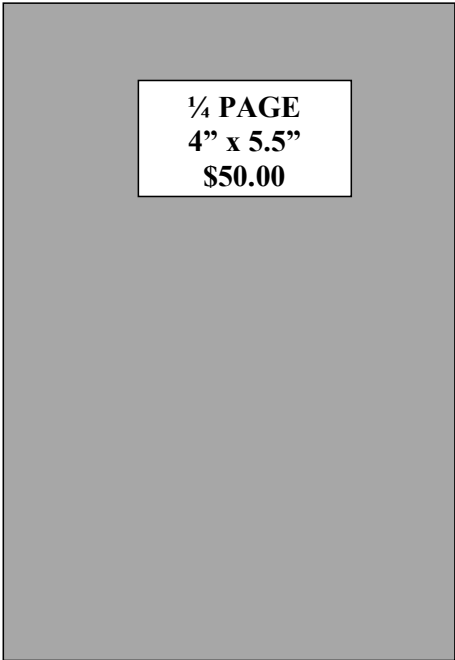

New Clubs Need Guiding Lions



I have been asked many times what does Lion's Insurance Policy provide. Many Lions have entirely different ideas about the coverage or I should say financial protection the Lions International Liability policy provides. Let's take a look at some things that are not covered under the Liability Policy. What is not covered is a great deal more than what is covered.

For Example: My Lions Club owns property and on the property is a Club House, or community center as the case may be. The Lions Insurance Policy covers only third party liability claims for an incident that occurs to a third party in a Lions event or project. The building (Club House) is not insured, renters of the Club House are not insured, users of the property that is not a Lions function are not insured. We are now beginning to see that the Lions Insurance policy has its limitations. Now let's go a couple of steps farther.

We have a lot of equipment that is of a mobile nature. That equipment is not insured. Now to further limit the coverage some entities require that they be a named insured, that really limits the coverage. Instead of \$1,000,000.00 in coverage once we add an entity as an additional insured we have cut the coverage in half, so instead of \$1,000,000.00 in protection we now have only \$500,000.00 in protection against a third party claim. Why! We have just insured another entity by having the other entity as an additional named insured, so we have a third party claim our, the Lions coverage is now at \$500,000.00 and the named insured is protected for \$500,000.00 in defense of a third party claim. So we have all sorts of limitations and/or areas of no insured protection at all.

Let's go one step further, the State of Alaska requires any employer who receives any monetary benefit from their services as an employee or by whatever other name they may be called be protected by Worker's Compensation Insurance. In Alaska private insurance companies provide this type of protection. If one is not eligible for coverage, due various underwriting limitations, there is the assigned risk pool. Now let's get with the problem most if not all Lions Clubs may have. They have workers, both Lions and non-Lions working on a project, for their service we pay a certain amount of money under any guise whatsoever, that is still payroll re-numeration as far as the State of Alaska is concerned and worker's compensation insurance is required. In some instances a volunteer organization with volunteer workers, who receive no monetary re-numeration in whatever manner, may be exempt for the Worker's Compensation Act of the State of Alaska. Now comes the catch, in order to be classified as exempt from Worker's Compensation Act a Lion's Club involved in such activity must request exemption from the State Act. This must be done in writing to the State of Alaska, Department of labor, Worker's Compensation Division and this request must be approved by the Worker's Compensation Board in writing to be exempt. This has to be done by each lions Club and stating the type of program serviced by volunteers. Now to illustrate how this works I will iterate certain fallacies that I have seen practiced. For Example; I'm a contractor and I don't want to pay worker's compensation so I declare all my employees to be sub-contractors. This is illegal and in violation of the State Act. A true sub-contractor bids to provide a certain type of work for a contractor and the sub-contractor has a business license, a performance bond, and insurance both liability and worker's compensation on file with the Contractor. See the difference? So be careful, any numeration paid to a volunteer under any name such monetary benefit is given is considered payroll by the State and subject amongst other things to the worker's compensation act.

Now let's go to another avenue of exposure. My Lion's Club has a park with amusement devices. The general public is allowed to use the facility, whether charged for or not. Lions Club Insurance has a limit of \$1,000,000.00 per occurrence. Does this really financially protect the Club and its membership? Some Clubs have incorporated to reduce the onus of members being involved, others have not. What should be considered for protections beyond the basic limit of liability coverage provided an umbrella policy raising the limits of liability protection. I will cite a good example in the news. GCI had invited guests to their lodge and were transporting the guests to a fishing camp nearby. Unfortunately tragedy occurred, basic coverage of \$1,000,000.00 per occurrence may not be enough financial protection thus and umbrella policy would pick up higher limits of financial protection. Now I will reiterate the Lion's Insurance. Third party claims only in any Lion's project and/or facility, occurrence limit of \$1,000,000.00. I would suggest each Club board review their operation and are they really financially protected from a third party claim or loss of any type, and are they conforming t the statutes of the State of Alaska?. The decision is yours. Any Insurance Agent can give you good advise.

## **Food Bank Reports**

April 17, 2010

The monthly food bank for April was conducted on Saturday, April 10, 2010 at the Lions Club House in Spenard.

Volunteers at the event totaled 31: 8 Lions from Spenard, 5 Spenard volunteers, 3 Lions from Mt. McKinley, 5 from the VA Domiciliary, and 10 people from the Cordova Center.

The total number of households served this month was 108 - the total family count was 481 members. Total number of donated hours was approximately 180 for this project. Approximately 5,800 pounds of goods were purchased and provided from TEFAP for distribution to area families.

Funds expended to support the Food distribution program between March and April were \$2,756 with Benton Bay Lions contributing \$500.

Rapid Action Mailing supplied the boxes used to package the food and Matt Dimmick of Keller-Williams Realty supplied his truck used to get food from the Food Bank.

May 9, 2010

The monthly food bank for May was conducted on Saturday, May 8, 2010 at the Lions Club House in Spenard. Volunteers at the event totaled 27: 9 Lions from Spenard, 3 Spenard volunteers, 3 Lions from Mt. McKinley, 2 from the VA Domiciliary, and 10 people from the Cordova Center.

The total number of households served this month was 72 - the total family count was 263 members. Total number of donated hours was approximately 160 for this project. Approximately 4,500 pounds of goods were provided from purchased and TEFAB resources for distribution to area families.

Funds expended to support the Food distribution program between April and May were \$1873.65. \$115.00 was donated for food purchases.

Rapid Action Mailing supplied the boxes used to package the food and Matt Dimmick of Keller-Williams Realty supplied his truck used to get food from the Food Bank.

June 22, 2010

The monthly food bank for March was conducted on Saturday, June 12, 2010 at the Lions Club House in Spenard.

Volunteers at the event totaled 25: 8 Lions from Spenard, 3 Spenard volunteers, 3 Lions from Mt. McKinley, 1 from the VA Domiciliary, and 10 people from the Cordova Center.

The total number of households served this month was 70 - the total family count was 246 members. Total number of donated hours was approximately 150 for this project. Approximately 4,900 pounds of goods were provided for TEFAP distribution to area families.

Funds expended to support the food distribution program between May and June were \$235.95, mainly through the use of reserve inventory of food on hand.

Rapid Action Mailing supplied the boxes used to package the food and Matt Dimmick of Keller-Williams Realty supplied his truck used to get food from the Food Bank.

July 10, 2010

The monthly food bank for March was conducted on Saturday, July 10, 2010 at the Lions Club House in Spenard.

Volunteers at the event totaled 19: 8 Lions from Spenard, 2 Spenard volunteers, 1 Lion from Mt. McKinley, 1 from the VA Domiciliary, and 7 people from the Cordova Center.

The total number of households served this month was 94 - the total family count was 368 members. Total number of donated hours was approximately 120 for this project. Approximately 6,000 pounds of goods were provided for TEFAP distribution to area families.

Funds expended to support the food distribution program between June and July were \$411.07, mainly because of the amount of food available through TEFAB stock.

Rapid Action Mailing supplied the boxes used to package the food and Matt Dimmick of Keller-Williams Realty supplied his truck used to get food from the Food Bank.

August 22, 2010

The monthly food bank for August was conducted on Saturday, August 14, 2010 at the Lions Club House in Spenard.

Volunteers at the event totaled 25: 7 Lions from Spenard, 5 Spenard volunteers, 4 Lions from Mt. McKinley, 2 from the VA Domiciliary, and 7 people from the Cordova Center.

The total number of households served this month was 112 - the total family count was 431 members. Total number of donated hours was approximately 120 for this project. Approximately 7,200 pounds of goods were provided for TEFAP distribution to area families.

Rapid Action Mailing supplied the boxes used to package the food

September 12, 2010

The monthly food bank for September was conducted on Saturday, September 11, 2010 at the Lions Club House in Spenard.

Volunteers at the event totaled 25: 8 Lions from Spenard, 5 Spenard volunteers, 2 Lions from Mt. McKinley, 2 from Tudor Road Bingo, and 8 people from the Cordova Center.

The total number of households served this month was 104 - the total family count was 391 members. Total number of donated hours was approximately 150 for this project. Approximately 7,350 pounds of goods were provided for TEFAP distribution to area families.

New Big Lake Recreation and Community Center needs your help

As some of you already know, the Big Lake Lions have taken on the project of building an indoor ice rink and rec center in Big Lake. The facility is next to the Lions Club and is a 26,000 sq ft building that will be non-heated for winter ice skating, astro turf for spring soccer, and roller hockey and basketball in the summer, along with other community events. The low overhead design is to allow low cost rental time for youth athletics, about \$50 per hour instead of \$200 an hour that they have to pay now.

At this time we have raised over \$600,000, the concrete is finished, and the metal building is being built. We hope to have the building finished within the next 30 days. We still need to raise \$200,000 for the infrastructure of the building; such as electrical, boilers, and the sprinkler system for fire suppression. We are offering 4'x4' permanent signs inside the building for a corporate \$5,000 donation to the project. We are asking all Lions to help us find 20 corporate sponsors to meet our goal and have this facility open for the winter hockey season.

If you have any ideas of a company that might be interested in helping us, we would greatly appreciate the lead and will get further information to them or make it available for you to get it to them. I have also attached some pictures of the progress we have made to this point.
